What is a GWAC?

A Governmentwide Acquisition Contract (GWAC) is defined as a task or delivery order contract for information technology.

- Established by one agency for governmentwide use
- Pre-competed, multiple-award, indefinite delivery, indefinite quantity (IDIQ) contract
- Operated by an executive agent designated by the OMB



GSA Small Business GWAC Division

- Develop, award and administer new small business GWACs
- Ensure contract compliance
- Conduct outreach and education to customers and industry
- Encourage small business set-asides

GWAC Features

- **Streamlined** — GWACs are pre-competed contracts offering a full range of contract types (all types of fixed-price, cost-reimbursement, labor-hour, and time-and-materials) to make procurement planning easier.
- **Flexible** — facilitate a total integrated solution on a single task order by providing access to ancillary support, such as products and services that are integral and necessary to an IT effort.
- **Socioeconomic Credit** — Small Business GWACs provide agencies with access to highly qualified small businesses and associated socioeconomic credit.

VETS GWAC

- 100% Service-Disabled Veteran-Owned Small Business (SDVOSB) Set-aside
- 44 Original Contract Holders
- Ordering Period: February 2, 2007 – February 1, 2017
- A result of Presidential Executive Order 13360

VETS GWAC (cont.)

- 330+ task order awards from 18 different agencies
- Over \$1.8 Billion in Total Obligated Sales
- Average task order dollar value is \$5.9 Million
- Largest task order award was over \$119 Million
- Average of 4 proposals per competed task order

VETS 2 - Draft RFP

- Draft RFP posted to FBO.gov on September 28th
- Open for comments through October 28th
- FAQs posted to Interact Page on November 13th



VETS 2 - Highlights

- 70 Awards
- SDVOSB Set-aside
- 31 Standardized Labor Categories (4 levels per category)
- Contract Types
 - Fixed Price, T&M, Labor Hour, Cost-Reimbursement
- Information Technology Services-based Solutions



VETS 2 – Evaluation Factors

- Relevant Experience Projects (maximum of 10)
- Additional Scoring for:
 - Foreign Experience
 - Task Order against a Multiple Award Contract
 - Larger Value Projects
 - Multiple Federal Government Customers
 - Breadth of Relevant Experience



VETS 2 – Evaluation Factors

- Past Performance
- Systems, Certifications, and Clearances
 - Cost Accounting System
 - CMMI(SVC or DEV)
 - ISO 9001, 20000, 27001
 - Government Facility Clearances
 - Secret or Top Secret



VETS 2 – Additional Information

- Highest technically rated with a fair and reasonable price
- Streamlined evaluation
 - Self-Scoring
- Offerors able to submit projects performed as either a prime contractor or subcontractor



VETS 2 – Additional Information

- All of the evaluation elements an Offeror is taking credit for must be in the Offeror's name
- Flexible teaming allowed at task order level
- Open Season allows GSA to add more SDVOSB contractors to VETS 2
