Enterprise Architecture and Strategy: Leads and evolves the VA Enterprise Architecture (EA) as an authoritative reference for information used to make informed decisions. Leads OIT Strategic Planning. Facilitates and supports VA Enterprise transformation efforts.

Enterprise Architecture (EA)

Consists of 2 Directorates:

- Enterprise Architecture- Responsible for establishing the authoritative reference for the requisite strategic, business, and technology information used to make informed decisions for VA. This includes end-to-end development and management of the VA EA, which describes the current and desired relationships among business/program management processes and information technology; and the required standards and tools to support VA EA development and use.
- <u>Strategy, Planning and Accountability</u>- Responsible for providing strategic planning and programming efforts to transform and modernize VA's IT business capabilities and ensure proper alignment to VA goals and objectives. This role also supports the VA IT environment to help formulate and measure the evolution of strategies and alignment of VA's overarching strategic plans, business goals and objectives.
